us, California was soon put under an Emergency Order. The signs began on March 9, 2020 when the Grand Princess Cruise ship docked in Oakland with more than 100 aboard were positive for coronavirus. Then on March 11, the state ordered the postponement or cancellation of large gatherings of more than 250 people. Then on March 16, the unthinkable happened, six bay area counties – San Francisco, Santa Clara, San Mateo, Marin, Contra Costa and Alameda, over 7 million people– issued a coordinated shelter-in-place order. Only essential businesses could continue to operate and soon after, the rest of the bay area followed along with all of California and eventually many parts of the country.




President's Message (continued):
